The Clovis Community College Board of Trustees held a regular meeting on Wednesday, August 6, 2025, at 8:00 a.m. in room 512.

### **NEW BUSINESS Instructional Matters**

Summer 2025 Graduation List:

The Board was presented with the list of Clovis Community College students who have met the requirements for graduation during the Summer 2025 term. Included in the list were 50 associate degree earners, 20 certificates of completion earners, and 41 certificates of achievement earners, for a total of 111 graduates. It was requested that the Board approve the Summer 2025 graduation list as submitted.

ACTION: Mondragon moved to approve the Summer 2025 graduation list as submitted. Bradburn seconded and upon roll call vote the motion carried (4-0).

# **NEW BUSINESS Non-Instructional Matters**

Governance Document:

Clovis Community College has a history of participatory governance where constituent groups are involved in decisions as much as possible. The updated Governance Document lays out how employees through Councils, Committees, and constituent groups can have input in CCC's decision-making processes. A summary of the major changes to the Governance Document was presented to the Board. The changes included updating the Mission Statement, the Transparency Statement, and the Councils and Committees; adding the Administrative Council; restructuring the President's Council; removing the Leadership Council and the Diversity, Equity, and Inclusion Committee; restructuring the Retention Council as the Retention Committee; and creating the Academic Affairs Council, the Strategic Enrollment Management Council, the Strategic Planning Committee, the Accreditation Committee, the Bookstore Committee, the Starfish Committee, and the Enrollment Strategies Committee.

ACTION: No action was requested of the Board of Trustees.

2025-2030 Strategic Plan:

The Board was presented with the Clovis Community College 2025-2030 Strategic Plan. The plan outlines a bold, collaborative vision for the future of the institution. It was developed through a comprehensive, data-informed process that included broad participation from employees, students, and community members, the plan affirms CCC's commitment to student success, employee engagement, facility enhancement, workforce alignment, and community partnership. The updated mission, vision, values, goals, and objectives serve as a roadmap to guide CCC's continued growth, innovation, and service to the region. It was requested that the Board approve the 2025-2030 Strategic Plan as submitted.

ACTION: Mondragon moved to approve the 2025-2030 Strategic Plan as submitted. Leal seconded and upon roll call vote the motion carried (4-0).

Employee Benefit Plans Review: The Board was presented with a summary of the Employee Benefit Plan for calendar year 2024. Clovis Community College offers two tax-sheltered benefit plans, which are available to employees on a voluntary basis. There is an institutional savings associated with tax-sheltered payments due to matching Federal Insurance Contribution Act (FICA) payments. Last year six employees participated in tax-sheltered 403(b) Plan providers, with contributions totaling \$6,010.00. Twenty-seven employees participated in the flexible spending plan, which allowed employees to tax shelter \$38,990.60. The total net savings to the College was \$4,693.98.

ACTION: No action was requested of the Board of Trustees.

Financial Actions Report for Fourth Quarter FY 2025:

The Board was presented with a copy of the Financial Actions Report for the fourth quarter of fiscal year 2025. It was requested that the Board approve the report for final submission to the New Mexico Higher Education Department.

ACTION: Mondragon moved to approve the Financial Actions Report for the fourth quarter of fiscal year 2025 as submitted. Bradburn seconded and upon roll call vote the motion carried (4-0).

Fiscal Year 2026 Proposed CHESS Budget:

The Board was presented with the Fiscal Year 2026 Proposed CHESS Budget. In 2021, Clovis Community College and five other New Mexico independent colleges formed the Collaborative for Higher Education Shared Services (CHESS) and entered into a Memorandum of Understanding (MOU) to implement an Enterprise Resource Planning (ERP) and Student Information System (SIS). These two applications are the mainstay for how higher education institutions maintain student data and services. CCC's portion of the budget for this year is \$2,090,976. The portions of the other colleges are based on their percentages outlined in the MOU. CCC receives funding from the state to help with our portion of the budget, and funds are available in the Workday ERP/ERP budgets. It was requested that the Board approve the Fiscal Year Proposed 2026 CHESS Budget for CCC through an existing Sole Source Procurement through the State of New Mexico.

ACTION: Mondragon moved to approve the Fiscal Year 2026 CHESS Budget for CCC as submitted. Bradburn seconded and upon roll call vote the motion carried (4-0).

### OTHER BUSINESS

President's Remarks:

Dr. Fuentes shared that Districts 1 and 4 on CCC's Board are up for election this year. The filing date is August 26, 2025.

He reminded everyone that the Fall semester begins on August 25 and registration is underway. Yard signs are available for anyone who would like to show support for CCC registration at home or at work.

CCC, as one of the presenting sponsors, will have a strong presence at the Curry County Fair. Our Registration, Recruitment, and Outreach teams will be on site, and Marketing and Communication has a full lineup of events planned. The CCC booth will be in the Commercial Building, and we will have a registration event on Wednesday night in the new Pavilion.

August 28 is CCC Night at the ENMU football game. More details will be shared soon, and employees and students will be invited to the game.

2025 CAS 25<sup>th</sup> Anniversary Season Lineup and Sponsorship: This year is the 25<sup>th</sup> year for our Cultural Arts Series. A flyer for the 2025/2026 season's lineup was presented to the Board. Information on becoming a season ticket holder or sponsor is included on the flyer. Dr. Fuentes mentioned several upcoming events and invited everyone to join us.

Dr. Fuentes shared the Calendar of August Events and highlighted the following events:

Fall registration continues through August 29 which is also the first week of classes.

CCC participated in the Back to School Expo on August 2 and the National Night Out on August 5. Dr. Fuentes and Dr. Kuykendall also visited students using a CCC vehicle to personally invite them to return to CCC.
