## **NEW BUSINESS Non-Instructional Matters**

Presidential Search Committee Membership: Chair Harlan presented the Trustees with the recommendations for the members of the Presidential Search Committee. She opened with a few words about ACCT's recommendations for selecting a liaison between the College and the ACCT consultant, Dr. Bill Holda, and his support people. The person should be an Administrator that will be the voice from the campus that helps with logistics, communication, forums, rooms, and notifications of public meetings. The person will work directly with the consultant to help ACCT be more efficient and to still be in the best interests of our employees and our community. Dr. Marcus Smith has been asked to serve in this capacity and he has agreed to serve. He will be assisting ACCT from the College side. He will work with Dr. Holda to reconcile all of the input from both CCC and the community that we serve as we put together the Presidential Search Committee. The composition of the committee was put together with input from the Trustees, the review of the 2019 list, and from the general recommendations from ACCT. ACCT's recommendations were not any names, they were positions, in the community and college. Dr. Smith visited with each of the individuals and confirmed the timeline of responsibility, the importance of the commitment of attendance, and their desire to serve. The list before the Trustees is the result of that process. The number of members on the list is within the range ACCT recommends. The members will review the applications, interview the semifinalists, and identify the five candidates for Board consideration. Two Public Forums will be held on October 25 to assist in the development of the Presidential Profile.

ACTION: Martin moved to approve the Presidential Search Committee as submitted. Bradburn seconded and upon roll call vote the motion carried (5-0).
