# **MINUTES**

**December 3, 2025 • 8:00 a.m. • Room 512**

The Clovis Community College Board of Trustees held a regular meeting on Wednesday, December 3, 2025, at 8:00 a.m. in room 512.

#### **MEMBERS PRESENT**

#### NEW BUSINESS Instructional Matters

*Fall 2025 Graduation List:*

The Board was presented with the list of Clovis Community College students who have met the requirements for graduation during the Fall 2025 term. Included in the list were 87 associate degree earners, 90 certificate of completion earners, and 148 certificate of achievement earners, for a total of 325 graduates. This is a 5% increase in graduates over the Fall 2024 term and includes a 10% increase in Associates degrees. It was requested that the Board of Trustees approve the Fall 2025 graduation list as submitted.

**ACTION: Martin moved to approve the Fall 2025 graduation list as submitted. Mondragon seconded and upon roll call vote the motion carried (4-0).**

#### NEW BUSINESS Non-Instructional Matters

*Budget Adjustment Request #1 for FY 2025-2026:*

The Board was presented with Budget Adjustment Request (BAR) #1 for FY 2025-2026. The request is to adjust budgets to allow for bringing cash balances to actuals as of 7/1/25; plant projects including roofing, parking lots, bathroom renovations, Cosmetology, Industrial Tech, campus flooring, and canopy upgrades; Capital Outlay for Severance Tax Bond Funds and GO Bond Funds; continued renovation of the Norman & Vi Petty Performing Arts Center; funds received for BRR, ERR, and Workforce Gro; grant revenue and associated expense adjustments based on funding letters. Upon approval from the Board, BAR #1 will be submitted to the New Mexico Higher Education Department. It was requested that the Board of Trustees approve Budget Adjustment Request #1 for Fiscal Year 2025-2026 as submitted.

**ACTION: Martin moved to approve the Budget Adjustment Request #1 for Fiscal Year 2025-2026 as submitted. Bradburn seconded and upon roll call vote the motion carried (4-0).**

#### OTHER BUSINESS

*President's Remarks:*

Dr. Fuentes introduced Annie Hogland, Curry County Clerk. Ms. Hogland expressed her appreciation to Clovis Community College for serving as a polling location for Curry County elections, noting that the campus is one of the most accessible and accommodating sites. She highlighted the welcoming hospitality of CCC staff and shared that the campus is a favorite voting location among community members. She also congratulated the recently elected CCC trustees, Ms. Laura Leal and Mr. Raymond Mondragon.

Dr. Fuentes noted the campus-wide event, Pancake Palooza, scheduled for Tuesday, December 9. All students, faculty, staff, and trustees are invited to attend.

He shared that the College is preparing for the upcoming Legislative Session. The first hearing on Higher Education will be next week in Santa Fe. Discussions are focusing on budget requests and other matters in preparation for the session that begins in January.

Dr. Fuentes highlighted exciting progress in our partnership with Eastern New Mexico University. Meetings are underway to strengthen transfer pathways from our institution to theirs.

CCC is participating in the Clovis Christmas Light parade on Saturday, December 6. The theme is "Favorite Christmas Movies" and he invited everyone to come out to see CCC's entry.

He concluded by thanking the entire CCC community for their hard work that contributed to a very successful Fall semester.
